**NOTICE OF EXTENSION OF COMMENT PERIOD FOR MODIFIED TEXT  
OF PROPOSED REGULATIONS**

*Supervision-Related Requirements*

**NOTICE IS HEREBY GIVEN** that the Board of Behavioral Sciences (Board) has proposed modifications made to proposed regulations in Title 16, California Code of Regulations (CCR) sections 1815.8, 1820, 1820.3, 1820.5, 1821, 1821.1, 1821.2, 1821.3, 1822, 1833, 1833.05, 1833.1, 1833.1.5, 1833.2, 1834, 1869, 1869.3, 1870, 1870.1, 1870.3, 1870.5, and 1871, related to supervision requirements.

These regulations were originally noticed on February 7, 2020, and the subject of a public hearing on March 23, 2020. The regulations were approved as modified by the Board at its March 5, 2021 meeting, and were noticed to the public for a 15-day comment period from April 16, 2021 to May 2, 2021. Additional modifications to the regulations were approved by the Board at its July 7, 2021 meeting, and were noticed to the public for a 15-day comment period from July 14, 2021 to July 29, 2021.

While a notice was sent previously to begin the comment period on the second modified text (noticed on July 14, 2021), not all persons may have received notice. Therefore, the Board is extending the end date of the second modified text comment period.

Written comments restricted to the most recent modifications made to the proposed modified regulations must be **received by the Board at its office no later than August 14, 2021.**
