The California Business and Professions Code stipulates the following reporting requirements for court clerks:

Crime or Liability for Death or Personal Injury

Within 10 days after a judgment by a court of this state that a person who holds a license, certificate, or other similar authority from the Board of Behavioral Sciences (Board) has committed a crime, or is liable for any death or personal injury resulting in a judgment for an amount in excess of thirty thousand dollars (\$30,000) caused by his or her negligence, error or omission in practice, or his or her rendering unauthorized professional services, the clerk of the court that rendered the judgment shall report that fact to the Board.

Felony Convictions

Within 48 hours after the conviction, the clerk of the court in which a licensee of the Board is convicted of a crime shall transmit a certified copy of the record of conviction to the Board.

Hearing Transcripts - Probation Reports

The clerk of the court shall transmit any felony preliminary hearing transcript concerning a defendant licensee to the Board as applicable, where the total length of the transcript is under 800 pages and shall notify the Board of any proceeding where the transcript exceeds that length. In any case where a probation report on a licensee is prepared for a court pursuant to Section 1203 of the Penal Code, a copy of that report shall be transmitted by the probation officer to the Board.
