^{→B} Name Change: If you have a name change that you would like processed with your renewal application, you must submit the *Notification of Name Change* form and all required documentation. Your renewal will not be processed until your name change has been processed. Do not send original documents unless specifically requested to do so.

INFORMATION FOR SECTIONS C & D

→**C** **Address:** Your renewal certificate will be mailed to the address written on your renewal form. This address is public information, and will be placed on the Internet pursuant to Business and Professions Code Section 27. If you do not want your home or work address available to the public, use an alternate mailing address.

→**D** **Conviction/Discipline:** Check the box next to "YES" if, since your last renewal, you have had any license ("license" includes registrations, certificates, or other means to engage in practice) disciplined by a government agency, or you have been convicted of, plead guilty to, or pled nolo contendere to any misdemeanor or felony in the United States, its territories, or a foreign country.

Convictions dismissed under sections 1203.4, 1203.4a, or 1203.41 of the Penal Code (or equivalent non-California law) must be disclosed. If you have obtained a dismissal of such a conviction, submit a certified copy of the court order. Do not include:

- Convictions prior to your 18th birthday unless you were charged as an adult
- Charges dismissed under section 1000.3 of the Penal Code
- Convictions under sections 11357(b), (c), (d), (e) or section 11360(b) of the Health and Safety Code which are two (2) years or older
- Traffic violations for which a fine of \$500 or less was imposed
- Infractions

"Discipline" includes, but is not limited to, suspension, revocation, voluntary surrender, probation or any other restriction. "License" includes professional registrations, certificates, or other means to engage in practice. It is not necessary to report disciplinary action taken by the California BBS.

IMPORTANT INFORMATION

RECEIPT OF RENEWAL

If you would like to know whether the Board has received your application, mail your application in a manner that includes tracking, or include a self-addressed stamped postcard or envelope, which will be mailed back to you upon receipt. To find out whether your application has been processed, check the [BreEZe online system](#). Once your renewal has been processed, your new expiration date will appear in this system.

EXPIRED REGISTRATION

If your renewal is not postmarked on or before your registration's expiration date, your registration will expire and hours of experience will not count during that time.

REGISTRATION RENEWAL LIMIT

Registrations may be renewed annually a maximum of FIVE times after initial registration with the board. When no further renewals are possible, you may apply for a new registration if you meet the requirements for registration in effect at the time of application for a subsequent registration.

EXAM REQUIREMENT

Registrants who have not yet passed the California Law and Ethics Exam must have taken the exam in the renewal cycle prior to renewing.

DISPLAY OF REGISTRATION

You are required to display your registration in a conspicuous place in the primary place of business.
