Subject: Licensing Report

Licenses Population

A total of 3,749 new registration/licenses were issued in the first quarter of FY 2022/2023. As of October 12, 2022, the Board has 131,580 licensees which is an approximate 1% gain since the fourth quarter of FY 2021/2022. This figure includes all licenses that have been issued and that are current and/or eligible to renew.
