

In mid-June, the Board Office reopened to serve the public during business hours. Board staff continues to work remotely with an ongoing rotating/staggered schedule for staff to work in the office with at least one manager onsite each day.

Office procedures were updated to include recommended protocols to protect both the public and Board staff. Board management placed 6-foot distance markers within the Board office; purchased disposable and washable face masks for all Board staff; purchased disposable gloves; and placed signs in the Board lobby and office identifying the maximum number of people permitted within a specific space. Hand sanitizer and disinfectant wipes were placed near all commonly used equipment (copiers, printers, fax machine). Additionally, Board staff are directed to enter and exit the office through entrances not accessible to the public.

Ten (10) examination development workshops were conducted from April 1, 2020 to June 30, 2020.

Enforcement Program

During the fourth quarter, the Enforcement staff received 351 consumer complaints and 167 criminal convictions. A total of 463 cases were closed and 8 cases were referred to the Attorney General's office for formal discipline. As of June 30, 2020, there were 115 cases pending at the Attorney General's Office. A total of 20 Accusations and 2 Statement of Issues were filed this quarter. The number of final citations for the fourth quarter was 8.

There was a total of 28 Final Disciplinary Orders. The average number of days to complete Formal Discipline in the fourth quarter was 407 days. This statistic is measured by the average number of days to complete the Enforcement process for cases investigated and transmitted to the AG's Office for formal discipline within the reference period. The Department of Consumer Affairs (DCA) Performance Measure to complete Formal Discipline is 540 days.

The average number of days the case is with the Attorney General's Office in the fourth quarter was 268. This statistic is measured from the date the Board refers the matter to the Attorney General's to the date the case is complete. The average number of days to complete all Board investigations in the fourth quarter was 62 days.

Transition to Pearson VUE

In the last Exam update Board staff reported that during the transition the Board experienced some difficulties with the interface between Pearson VUE and the Board's computer systems. At the time of this report these difficulties have been resolved and communication through the interface is working. Board staff continues to monitor the interface and address issues as soon as they are discovered. Through combined effort of Board staff, Pearson VUE and the Department's Office of Information Services the interface as fully functioning.

The Impact of COVID-19

In March of 2020, Pearson Vue made the decision to close test sites in order to stop or slow the spread of COVID-19. Currently Pearson VUE sites are now open with a decreased capacity due to the need to create a safe test environment through social distancing. Recognizing the need to both maintain social distancing and get people into the exam as soon as possible Pearson VUE, in consultation with the Board, opened third-party test sites in order to increase capacity.

Even with the re-opening of test sites and the Board's allowance of third-party sites an unprecedented slowdown in test administrations occurred for the fourth quarter. During this fourth quarter 2,739 exams were administered which approximately 46% less

exams administered from FY 2018/19 in which 5,052 exams were administered. This is attributed to the complete shutdown of testing administration in April. In July the exams administered has increased significantly, but this number is still below last year's numbers.

Because the continued impact of COVID -19 remains an issue the Board is estimating that complications with scheduling could continue until the end of the year. Scheduling complications have a significant impact on candidates who are required to participate in an exam before their eligibility expiration date expires. They also have an impact on registrants who need to participate in an exam in order to renew or obtain a subsequent registration number.

Pursuant to the Governor's Executive Order N-39-20, three waivers were enacted to minimize the impact the testing administration slow down. On May 29, 2020, these waivers have been extended and the Board continues to work with the Department on considering future waivers. Currently these are the three waivers that have been implemented concerning examinations:

- A six-month extension of examination eligibility for exam Board exam candidates that failed the clinical examination (for LMFT, LCSW, or LPCC applicants) or the written examination (for LEP applicants), and whose one-year eligibility to re-take the examination expired between March 31, 2020 and July 1, 2020.
- The waiving of the requirement that associates must pass the California law and ethics examination before a subsequent registration number is issued. The waiver applies to all associates who are in their last year of renewal, if that renewal expires between March 31, 2020 and June 30, 2020. This wavier has now been extended for associates whose registration expires between March 31, 2020 and August 31, 2020.
- The waiving of the requirement that associates must participate in the California law and ethics exam in order to renew their associate registration. The waiver applies to all associates that have a registration that expires between March 31 and June 30, 2020.

Exam Scheduling Challenges

Appointment availability continues to change due to COVID-19. In order to comply with local measures and maintain appropriate safety measures, Pearson VUE test sites are having to adjust testing schedules on a continual basis. While this is unfortunate, it has been valuable in ensuring the safety of our exam candidates while maintaining the highest volume possible of test administrations. To increase testing capacity some Pearson VUE test centers in the United States are extending their hours to be open nearly 24 hours a day.

Candidates who have scheduled an exam may have their exam cancelled in order to comply with the ever-changing guidance from health and government organizations. When this happens, Pearson VUE will move the scheduled exam to a temporary

appointment-holding test center to allow time to reschedule an appointment. Candidates should receive an email informing them of this change, but in some circumstances, this can end up in a spam folder or be blocked by the recipient's email provider. Candidates will then be able to reschedule their exam, free of charge, through their online candidate profile.

The Board and Pearson VUE are encouraging each candidate to check their online candidate profile on a regular basis to ensure they have the most up to date information concerning their scheduled exam. Also, the online scheduling system has the most up to date information concerning testing appointment availability.

Test Site Concerns

Pearson VUE-owned test centers that are open are following social distancing requirements and strict cleaning regiments. Test centers may need to limit workstation availability to ensure that local social distancing requirements can be maintained between candidates, which is why some exam appointments have been canceled at test centers that are open for exam delivery at this time. Pearson VUE third party sites that are still open and operational are being encouraged to follow guidance from local governments and health authorities, including social distancing requirements, at their test centers.

Finally, Board staff has been in consultation with candidates who are immune-compromised or have health concerns that they believe will necessitate a private room for testing. This is an option, but to exercise this option candidates need to go through the special accommodations process which requires obtaining a note from a physician that explains the medical need for a private room. It is important to note that each site has only one private room, so availability is limited, which means it is vital to plan and schedule as far in advance as possible.

Communication Report

Social Media

The board continues to increase its social media presence and has been receiving positive feedback from stakeholders.

Facebook

There has been significant increase of likes for the Board's Facebook page since January 2020 when a concerted effort was made to better utilize this platform. During that time, the likes have increased 87% from 4,614 to 8,630. Our Wednesday morning processing date posts are still our most popular with noticeable spikes when analyzing the data. We currently have 9,545 followers.

We are continuing our Facebook Fridays with the BBS. From 2:00 p.m.–3:00 p.m. each week, we will discuss a new important topic for approximately 30 minutes and then

answer questions from the audience. During this quarter the following topics have been discussed:


Twitter analytics do not provide the number of followers, but they do show the number of times people are seeing our tweets. The average number of views per month for this quarter are as follows:

<u>Department of Consumer Affairs Call Center Update</u>

In January of 2020, Board staff began working with the Department of Consumer Affairs (DCA) on a plan to utilize the services of DCA's Call Center. After several meetings and training sessions with DCA Call Center staff, the Board officially transitioned its phone system to DCA. The Call Center has nine staff members who are trained to answer basic questions and to transfer calls to appropriate units if the questions are too complicated to be answered over the phone.

This transition has dramatically lowered hold wait times. The average wait time for a call to be answered is between thirty seconds and one minute. The highest number of calls received in one day was 151 calls on March 10, 2020, and the lowest number of calls was 58 calls on April 24, 2020. On average, the Board receives between 75-100 calls in a day.


