SUBJECT: LICENSED PROFESSIONAL CLINICAL COUNSELOR ACT

<u>Summary</u>

This bill would remove the following requirements for professional clinical counselor (LPCC) licensure:

- The requirement to gain at least 150 hours of clinical experience in a hospital or community mental health setting; and
- The requirement that LPCCs must complete specified education, supervised experience, and continuing education in order to treat couples or families.

Existing Law

- **1)** Defines a "community mental health setting" as a clinical setting that meets all of the following (Business and Professions Code (BPC) §4999.12(o):
 - a) Lawfully and regularly provides mental health counseling or psychotherapy;
 - **b)** Clients routinely receive psychopharmacological interventions in conjunction with psychotherapy, counseling, or other psycho-social interventions;
 - c) Clients receive coordinated care that includes the collaboration of mental health providers; and
 - d) Is not a private practice.
- 2) Requires applicants for an LPCC license to obtain at least 150 hours of clinical experience in a hospital or community mental health setting. (BPC §4999.46(c)(4))
- **3)** Requires LPCCs who wish to assess and treat couples and families to complete the following additional training and education: (BPC §4999.20(a)(3))

- a) Either 6 semester/9 quarter units specifically focused on the theory and application of marriage and family therapy, or a named specialization or emphasis area in marriage and family therapy in the qualifying degree;
- **b)** At least 500 hours of supervised experience working directly with couples, families, or children; and
- c) Completion of at least 6 continuing education hours specific to marriage and family therapy in each renewal cycle.
- 4) Requires LPCC supervisors who wish to supervise any associate marriage and family therapist, marriage and family therapist trainee, or who wish to supervise an associate professional clinical counselor or LPCC licensee who is seeking experience to treat couples and families, to meet the above-listed additional education and training requirements to treat couples and families. (BPC §§4980.03(g)(2), 4999.12(h)(2))
- **5)** Requires LPCCs who wish to treat couples and families to obtain written confirmation from the Board that they meet the requirements, and to provide a copy of the written confirmation to their clients prior to beginning couples or family treatment. (California Code of Regulations (CCR) Title 16, §1820.7(a))
- 6) Requires LPCCs acting as a supervisor for an associate marriage and family therapist, marriage and family therapist trainee, or an LPCC or associate professional clinical counselor gaining supervised experience to treat couples and families, to provide the written confirmation letter to their supervisees prior to beginning supervision. (16 CCR §1820.7(b))

<u>This Bill</u>

- Removes the requirement that applicants for an LPCC license must obtain at least 150 hours of clinical supervised experience in a hospital or community mental health setting. (deletes BPC §4999.46(c)(4))
- 2) Removes the requirement that LPCCs who wish to assess or treat couples and families complete certain additional education, supervised experience, and continuing education related to marriage and family therapy. (deletes BPC §4999.20(a)(3))

Comments

1) Author's Intent. This bill is sponsored by the California Association for Licensed Professional Clinical Counselors (CALPCC). The sponsor notes that the requirement to complete 150 hours in a community mental health setting or hospital is outside the standard practice for post-graduate experience requirements for the LPCC license nationally. In addition, they note that to get these hours, an associate professional clinical counselor often needs to interrupt or leave their employment to find a short-term job at one of these sites, and that such a placement is difficult to find because of adversity to hiring short-term employees. Therefore, the requirement is a barrier to licensure.

The sponsor also notes that of the 50 states, only California prohibits LPCCs from assessing and treating couples and families without additional specific training.

- 2) Additional Research. CALPCC has compiled two research documents to support its proposal:
 - Attachment A provides pertinent sections of the LPCC licensing law that identifies where LPCCs receive couples and families education and experience. These were identified by several educators taking into account how the requirements are met in the various curricula.
 - Attachment B provides an overview of other state's laws that relate to LPCCs working with couples and families.
- **3) History.** LPCCs were granted licensure in California with the passage of SB 788 (Chapter 619, Statutes of 2009). With this bill, California became the 50th state to license LPCCs. The requirement for additional education and experience for LPCCs to treat couples and families, and the requirement for 150 hours of experience in a hospital or community mental health setting were added to the bill as part of the negotiation process.
- **4) Current Challenges.** Board staff notes the following challenges encountered by requiring additional education and experience for LPCCs to treat couples and families, and 150 hours of experience in a hospital or community mental health setting:
 - a) Definition of Community Mental Health Setting Causes Confusion_Current law defines a community mental health setting as meeting all of the following:
 - (1) Lawfully and regularly provides mental health counseling or psychotherapy.

(2) Clients routinely receive psychopharmacological interventions in conjunction with psychotherapy, counseling, or other psycho-social interventions.

(3) Clients receive coordinated care that includes the collaboration of mental health providers.

(4) Is not a private practice.

This requirement was intended to provide experience in community mental health with psychopharmacologic interventions in a hospital or community mental health setting. However, APCCs frequently are confused or unclear if the setting they have found is acceptable toward these requirements. Sometimes the associate finds a site that seems to meet the above criteria but is not necessarily a community mental health center or hospital. b) Difficulty Finding Hours in a Community Mental Health Setting_Associates sometimes call the Board to report that they have finished all their hours, except they are unable to find a site that will hire them to complete this requirement. They report that because the requirement is so few hours, sites are reluctant to hire and train them, knowing that they likely won't stay long term.

c) Letter to Verify Couples and Families Requirements Met

Once an LPCC has fulfilled the additional education and experience to treat couples and families, they are issued a letter from the Board authorizing them to do so. However, to keep the authorization current, they need to continue to complete 6 hours of continuing education specific to marriage and family therapy every renewal cycle. However, the Board has no way to know if an LPCC who has opted to treat couples and families continues to complete this continuing education at every renewal, except via audit. And it would be perfectly acceptable for an LPCC to decide they no longer wished to treat couples and families, and not complete the continuing education (as long as they ceased treating couples and families.) However, the authorization letter from the Board is issued in perpetuity, creating a situation where individuals with the letter may not actually meet all requirements any longer.

d) Supervision Issues for LPCCs

LPCCs are not permitted to supervise AMFTs unless they meet the additional requirements to treat couples and families. This can act as a disincentive to hire an LPCC if they are not able to supervise all types of associates that an agency might hire.

e) Reluctance to Hire LPCCs

The Board has generally gotten reports of some agencies being reluctant to hire LPCCs because of confusion about whether they meet the requirements to treat couples and families, and the continuing verification requirements.

f) License Portability Issues

The fact that all other states permit LPCCs to treat couples and families can cause confusion and a barrier to licensure for some LPCC applicants who are licensed in other states.

If the LPCC applicant has been licensed in another state that permits treatment of couples and families for at least 2 years and otherwise successfully meets the requirements for the licensure by credential pathway, then current law allows them to treat couples and families as long as they continue to complete the 6 hour continuing education requirement each renewal cycle. However, if they do not qualify for the licensure by credential pathway, then they must meet all of the additional requirements to treat couples and families.

- **5)** Additional Amendments Needed. If the bill is successful, several additional subsections in LMFT and LPCC statute related to the deleted requirements would become obsolete. Therefore, staff recommends requesting the following amendments be included in the bill to maintain clarity of the law:
 - Strike BPC §§4980.03(g)(2): This subparagraph requires LPCC supervisors of pre-licensed LMFT applicants to meet the additional education, experience, and continuing education requirements to treat couples and families.
 - Strike 4999.12(h)(2): This subparagraph requires LPCC supervisors of prelicensed LMFT applicants, or LPCCs or APCCs seeking experience to treat couples and families to meet the additional education, experience, and continuing education requirements.
 - Strike 4999.12(o): This subdivision defines a "community mental health setting" for purposes of the 150-hour clinical experience requirement in BPC §4999.46(c)(4).
 - Strike 4999.60(b): This subdivision permits out-of-state applicants who qualify for licensure by credential to treat couples and families under certain circumstances.

The sponsor has also indicated they will be making the following amendment:

- Amend Family Code §3110.5(c)(5): This section will be amended to delete the reference to the additional requirements for LPCCs to treat couples and families.
- 6) Policy and Advocacy Committee Recommendation. At its April 16, 2021 meeting, the Policy and Advocacy Committee recommended that the Board consider taking a "support" position on this bill.

ASSEMBLY BILL

No. 462

Introduced by Assembly Member Carrillo

February 8, 2021

An act to amend Sections 4999.20 and 4999.46 of the Business and Professions Code, relating to healing arts.

legislative counsel's digest

AB 462, as introduced, Carrillo. Licensed Professional Clinical Counselor Act.

Existing law, the Licensed Professional Clinical Counselor Act, prohibits, except as provided, a person from practicing or advertising the performance of professional clinical counseling services without a license. The act defines "professional clinical counseling" to exclude the assessment or treatment of couples or families unless the professional clinical counselor has completed specified training and education requirements. The act requires supervised experience that is obtained for the purpose of qualifying for licensure to be related to the practice of professional clinical counseling and comply with specified requirements, including by requiring at least 150 hours of clinical experience in a hospital or community mental health setting, as defined. A violation of the act is punishable as a misdemeanor.

This bill would delete the provision excluding the assessment or treatment of couples or families without meeting specified training and education requirements from the definition of "professional clinical counseling." The bill would also eliminate the licensure requirement of completing at least 150 hours of clinical experience in a hospital or community mental health setting. By widening the scope of activity subject to licensure as a professional clinical counselor, this bill would

expand the scope of a crime and would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

Vote: majority. Appropriation: no. Fiscal committee: yes. State-mandated local program: yes.

The people of the State of California do enact as follows:

SECTION 1. Section 4999.20 of the Business and Professions
 Code is amended to read:

3 4999.20. (a) (1) "Professional clinical counseling" means the 4 application of counseling interventions and psychotherapeutic 5 techniques to identify and remediate cognitive, mental, and 6 emotional issues, including personal growth, adjustment to 7 disability, crisis intervention, and psychosocial and environmental 8 problems, and the use, application, and integration of the 9 coursework and training required by Sections 4999.32 and 4999.33. 10 "Professional clinical counseling" includes conducting assessments for the purpose of establishing counseling goals and objectives to 11

12 empower individuals to deal adequately with life situations, reduce
13 stress, experience growth, change behavior, and make
14 well-informed, rational decisions.

(2) "Professional clinical counseling" is focused exclusively on
the application of counseling interventions and psychotherapeutic
techniques for the purposes of improving mental health, and is not
intended to capture other, nonclinical forms of counseling for the
purposes of licensure. For purposes of this paragraph, "nonclinical"
means nonmental health.

21 (3) "Professional clinical counseling" does not include the

22 assessment or treatment of couples or families unless the

23 professional clinical counselor has completed all of the following

24 training and education:

25 (A) One of the following:

26 (i) Six semester units or nine quarter units specifically focused

27 on the theory and application of marriage and family therapy.

(3) "Professional clinical counseling" does not include theprovision of clinical social work services.

13 (b) "Counseling interventions and psychotherapeutic techniques" 14 means the application of cognitive, affective, verbal or nonverbal, 15 systemic or holistic counseling strategies that include principles 16 of development, wellness, and maladjustment that reflect a 17 pluralistic society. These interventions and techniques are specifically implemented in the context of a professional clinical 18 19 counseling relationship and use a variety of counseling theories 20 and approaches.

21 (c) "Assessment" means selecting, administering, scoring, and 22 interpreting tests, instruments, and other tools and methods 23 designed to measure an individual's attitudes, abilities, aptitudes, 24 achievements, interests, personal characteristics, disabilities, and 25 mental, emotional, and behavioral concerns and development and 26 the use of methods and techniques for understanding human 27 behavior in relation to coping with, adapting to, or ameliorating 28 changing life situations, as part of the counseling process. 29 "Assessment" shall not include the use of projective techniques 30 in the assessment of personality, individually administered 31 intelligence tests, neuropsychological testing, or utilization of a 32 battery of three or more tests to determine the presence of 33 psychosis, dementia, amnesia, cognitive impairment, or criminal 34 behavior.

(d) Professional clinical counselors shall refer clients to other
 licensed health care professionals when they identify issues beyond

37 their own scope of education, training, and experience.

38 SEC. 2. Section 4999.46 of the Business and Professions Code39 is amended to read:

4999.46. (a) Except as provided in subdivision (b), all 2 applicants shall have an active associate registration with the board 3 in order to gain postdegree hours of supervised experience. (b) (1) Preregistered postdegree hours of experience shall be 4 5 credited toward licensure if all of the following apply: (A) The registration applicant applies for the associate 6 7 registration and the board receives the application within 90 days 8 of the granting of the qualifying master's degree or doctoral degree. (B) For applicants completing graduate study on or after January 9 10 1, 2020, the experience is obtained at a workplace that, prior to 11 the registration applicant gaining supervised experience hours, requires completed Live Scan fingerprinting. The applicant shall 12 13 provide the board with a copy of that completed State of California "Request for Live Scan Service" form with their application for 14 15 licensure. 16 (C) The board subsequently grants the associate registration. 17 (2) The applicant shall not be employed or volunteer in a private

practice until they have been issued an associate registration by 18 19 the board.

20 (c) Supervised experience that is obtained for the purposes of 21 qualifying for licensure shall be related to the practice of 22 professional clinical counseling and comply with the following:

23 (1) A minimum of 3,000 postdegree hours performed over a 24 period of not less than two years (104 weeks).

25 (2) Not more than 40 hours in any seven consecutive days.

26 (3) Not less than 1,750 hours of direct clinical counseling with 27 individuals, groups, couples, or families using a variety of 28 psychotherapeutic techniques and recognized counseling 29 interventions.

30 (4) Not less than 150 hours of clinical experience in a hospital 31 or community mental health setting, as defined in Section 4999.12. 32 (5)

33 (4) A maximum of 1,250 hours of nonclinical practice, 34 consisting of direct supervisor contact, administering and evaluating psychological tests, writing clinical reports, writing 35 progress or process notes, client centered advocacy, and workshops, 36 37 seminars, training sessions, or conferences directly related to professional clinical counseling that have been approved by the 38 39 applicant's supervisor.

(5) A maximum of 1,200 hours gained under the supervision
of a licensed educational psychologist providing educationally
related mental health services that are consistent with the scope
of practice of an educational psychologist, as specified in Section

6 (d) An individual who submits an application for licensure 7 between January 1, 2016, and December 31, 2020, may 8 alternatively qualify under the experience requirements of this 9 section that were in place on January 1, 2015.

(e) Experience hours shall not have been gained more than six
years prior to the date the application for licensure was received
by the board.

Licensed Professional Clinical Counselors Licensing

Excerpts of current requirements for LPCC Licensure (Business and Professions Code (BPC) Sections 4999.30-4999.66) with specific elements highlighted that reflect requirements for education and training that relate to couples and families.

OVERVIEW OF LPC AUTHORITY TO WORK WITH COUPLES AND FAMILIES

The following table presents a State-by-State Overview of LPC Authority to Treat Couples and Families.

The information in this table was compiled through a review of *Licensure Requirements for Professional Counselors, A State-by-State Report, 2016 Edition*, published by the American Counseling Association (ACA) (2016 Requirements) which is attached by reference, and by a review of the websites, laws, and regulations of the state professional counselor regulatory boards. In addition, a review of licensing laws showing Changes in Licensure Requirements for Professional Counselors Since 2016 is also attached but is not referenced in the table. The page references in the table are to the location of the information in Appendix H, Scope of Practice to the 2016 Requirements. The "see reference below" in the table refers to additional information and to the website links listed in this document below the table where the information may be found.

The table shows:

- California is the only state that requires a licensed LPC (termed LPCC in California) to meet additional education or training/experience requirements in order to assess or counsel with couples or families.
- California is the only state that requires a licensed LPC to meet additional continuing education (CE) requirements in order to continue to work with couples and families.
- California is the only state that prohibits a licensed LPC from working with couples or families unless they receive additional education or training.

- 34 states refer to LPCs working with couples/marriage and families in the authorizing statute, regulations, or LPC scope of practice.
- 6 states refer to LPCs working with families in the authorizing statute, regulations, or LPC scope of practice.
- 1 state refers to LPCs working with couples/marriage in the authorizing statute, regulations, or LPC scope of practice.
- 3 states refer to LPCs working with clients throughout the life span.

Incomplete data was found for five States: Delaware, Georgia, Kansas, New Hampshire, Utah. Since this is envisioned as a dynamic document, the information on those states will be updated later as information becomes available.
