**Subject: Telehealth Listening Sessions** 

Board staff will be conducting a telehealth listening session in September 2022 to gain additional input from stakeholders that will assist the committee in planning its future efforts. The listening session will be to Board staff, stakeholders, and the public, via a virtual platform. Board staff will facilitate the session and will report back to the committee on the information that was presented.

To coordinate this event Board staff will be sending out a survey to stakeholders to determine topics of concern and to seek presenters for the event. Presentations are anticipated to be approximately 10 to 15 minutes long. Once the survey responses are collected, Board staff will select and schedule the presenters. Depending on the level of interest in presenting, an additional listening session may be considered.

A draft of the survey is attached. To ensure sufficient time for planning the survey will be distributed on June 17<sup>th</sup> and will have a close date of July 31<sup>st</sup>.
