Subject: Results of the Licensure Pathway Survey

Background

At its March 2024 meeting the Board finalized the Licensure Pathway Survey. This survey was developed to seek input from Board registrants and licensees about barriers that they are facing, or may have faced, during the pathway to licensure. The survey consisted of thirty questions organized into three thematic segments that relate to the major milestones of the licensure pathway:

- Education Experience
- Supervision Experience
- Examination Experience

For each major milestone, the survey asked for details about a participants experience, how effective this experience was in preparing them for the next licensure milestone, and to what extent certain factors may have presented a barrier in obtaining that milestone. Also, the survey allowed for participants to include comments and additional information for each milestone.

On March 18, 2024 the survey was posted to the Board's social media pages and distributed through the Board's email subscribers list. The survey closed on April 9, 2024 and resulted in 3,170 complete responses. Attached is a summary of the responses for registrants (Attachment A - Registrant Licensure Pathway Survey) and a summary of responses for licensees (Attachment B - Licensee Licensure Pathway Survey).

Theses summaries do not include results for questions two through four that focus on a participant's graduation and licensing dates. Additionally, the free form responses and comments have not been included. Board staff will be conducting a more in-depth analysis of all survey results that will include those items that are not presented in summary reports. This report will be presented at a future Committee meeting.

In the interim, included in the materials is a general summary of the participant population and responses to the questions that asked participants to rate the impact certain factors

may have posed a barrier to achieving a licensing milestone (Attachment C – General Summary of Participants and Significant Barriers Responses).

Recommendation

Conduct an open discussion regarding the survey responses and identify areas that warrant closer examination by staff during the analysis of the survey data.



Q1 Are you currently a registrant or licensee? (Select all that apply)





Q7 Did you attend school full time during your graduate program?






Q8 While attending your graduate program, in addition to practicum hours, how many hours did you work?







Q11 How difficult was it for you to find a supervisor?






Q12 How many clinical supervisors do you/or have you had?


Q18 How much did supervision cost you per month?


Q28 How much did you spend on course preparation programs or courses?

Q7 Did you attend school full time during your graduate program?






Q12 How many clinical supervisors do you/or have you had?


Q18 How much did supervision cost you per month?








Q22 Did you have to retake the CA Law and Ethics Examination?
