Subject: Discussion and Possible Recommendations Regarding Education

Requirements for Licensed Marriage and Family Therapists (Business and Professions Code (BPC) §§4980.36, 4980.37, 4980.41, 4980.74,

4980.78, 4980.81)

During its last meeting, the committee discussed conducting a comprehensive review of the education requirements for Licensed Marriage and Family Therapists (LMFTs). The goal of this review is to identify ways to eliminate any confusion and inequalities resulting from the current multi-pathway structure of LMFT education requirements.

Background

In 2010, the LMFT education requirements were amended in response to the passage of the Mental Health Service Act (MHSA). The MHSA emphasized wellness, client/driven systems, and culturally competent public mental health care. These amendments transitioned the education requirements from a content-based model to a more competency and integrated degree model. Additionally in 2014, the board established a pathway for individuals who earned their degrees from out-of-state institutions. Currently, there are three primary educational pathways for LMFT applicants:

- **Pre-2012:** In-state degrees completed by those who began graduate study before August 1, 2012. (BPC §§ 4980.37, 4980.41)
- **Post-2012:** In-state degrees completed by those who began graduate study on or after August 1, 2012. (BPC § 4980.36)
- Out-of-state (OOS): Out-of-State degrees, regardless of date, governed by "substantial equivalency" standards. (BPC §§ 4980.78, 4980.81)

The Pre-2012 and OOS requirements seek to ensure that an applicant's education is comparable to Post-2012 requirements and allows for the remediation of any gaps that may exist.

When considering the education requirements for LMFT licensure it will be important for the committee to consider the following three questions:

1. Does a degree program need to be an integrated course of study?

The requirement for an integrated degree program has created challenges for out-of-state applicants who may have received equivalent training through separate, modular coursework but are excluded if their program is not formally classified as integrated. Additionally, the term "integrated degree" lacks a consistent definition across jurisdictions, causing confusion for applicants and students and placing the burden on the Board to interpret and evaluate coursework on a case-by-case basis.

2. Should the education requirements focus on content, competency or both?

Content requirements and competency requirements differ in both focus and evaluation. Content requirements specify the subjects or courses a student must complete, such as human development, law and ethics, or psychotherapy. These are objectively verified through course titles and unit counts on a transcript, ensuring that the students has been exposed to specific topic areas. In contrast, competency requirements focus on what the student is able to do with their education such as conducting assessments, applying ethical standards, or developing treatment plans. Rather than just verifying course completion, competency-based education assesses whether students have mastered and can apply the necessary skills and knowledge for professional practice.

3. <u>Is it feasible to define a degree program as in-state or out-of-state?</u>

Historically, the Board has classified institutions as in-state or out-of-state based on their physical location. With the rise of online graduate programs, this method is no longer feasible, causing confusion about the licensure pathways and coursework remediation. For example, Post-2012 in-state applicants cannot remediate education, while out-of-state applicants can remediate 12 to 18 units while registered as associates.

Comparison of Key Educational Components

Staff has reviewed and compared each pathway to identify existing standards and potential differences that could create barriers or confusion. The following are the key components to the LMFT education requirements that will guide future discussion (**Attachment A**):

1. **Accreditation:** Post-2012 degrees must be from institutions "...approved by the Bureau for Private Postsecondary Education or accredited by either the Commission on Accreditation for Marriage and Family Therapy Education, or a regional or national institutional accrediting agency that is recognized by the

United States Department of Education." Unlike Post-2012, Pre-2012 requirements do not name the Commission on Accreditation for Marriage and Family Therapy Education (COAMFTE) as a specific accrediting agency that is acceptable. OOS degree requirements simply state that the degree must be from an accredited or approved institution.

- 2. Degree Title: Both Pre-2012 and Post-2012 require that the degree must be in "...marriage, family, and child counseling, marriage and family therapy, couple and family therapy, psychology, clinical psychology, counseling psychology, or either counseling or clinical mental health counseling with an emphasis in either marriage, family, and child counseling or marriage and family therapy." For OOS state degrees the degree title does not need to be identical to those that are required for in-state degrees but must be "substantially equivalent" to what is required for an in-state degree.
- 3. **Degree Units:** Pre-2012 and OOS degrees are required to have a minimum of 48 semester units or 72 quarter units. Post-2012 degrees are required to be a minimum of 60 semester units or 90 quarter units.
- 4. Remediations: For applicants with Pre-2012 degrees, remediation focuses on ensuring that the applicant has completed any necessary coursework now required under the current standards but not required at the time their degree was earned. For OOS degree holders, remediation is more comprehensive. Because OOS programs may not align with California's specific statutory and regulatory content and competency requirements, these applicants are evaluated under "substantial equivalency" standards. All applicants, except Post-2012 degree holders, can remediate any gaps in education (e.g. child abuse assessment, spousal/partner abuse, or California Law & Ethics) while a registrant, but must complete all required when applying for licensure.
- **5. Practicum:** Pre-2012 degrees require 6 semester or 9 quarter units and 150 face-to-face experience hours. Post-2012 and OOS degrees require 6 semester or 9 quarter units and 225 face-to-face hours, with up to 75 hours allowed in client centered advocacy. If an out-of-state applicant is currently licensed in another state at the highest level and they are exempt from this requirement.
- 6. Core Content and Competencies: The LMFT education requirements for each pathway are currently dispersed across various statutes and regulations. This fragmented structure can make it challenging for applicants, educators, and other stakeholders to navigate and fully comprehend the requirements. Additionally, there is no standardized language defining the competency areas needed for each pathway.

Suggested Approach

To establish consistent and equitable standards for the LMFT education requirements the committee should consider creating a single pathway for education based upon the comprehensive and updated requirements for Post-2012 outlined in BPC § 4980.36. This section reflects a modern, integrated model that includes essential competencies such as trauma-informed care, cultural responsiveness, public mental health principles, and evidence-based practice.

In considering changes to the LMFT education requirements, the committee will need to consider taking the following actions:

- Identify the core content areas for LMFT licensure, including required coursework topics and unit totals.
- Define the core competencies essential for safe and competent service delivery in California and ensure consistent use of terminology across statutes and regulations.
- Determine whether a qualifying degree must be an integrated degree program.
- Clearly define which content areas are eligible for remediation and establishing whether remediation must be completed prior to registration and if it may be satisfied through continuing education or graduate-level coursework.
- Ensure that practicum requirements are clearly defined, aligned with national standards, and provide students with sufficient clinical experience.

Recommendation

Conduct an open discussion on the approach to reviewing LMFT education requirements, including identifying any additional areas of concern. Direct staff to review LMFT education requirements in other states, as well as standards set by LMFT accrediting agencies, and to develop draft language for further consideration and discussion.
