### Outreach Events

During the first quarter of FY 2025/26, Board staff conducted 12 virtual outreach presentations for a variety of schools and professional associations. Staff also represented the Board at the Annual CAMFT Conference and participated in NASW Lobby Days. Additionally, Board staff is scheduled to attend the NASW-CA Conference in Irvine in November. Currently, there are 11 outreach presentations scheduled for FY 2025/26 (Attachment A)

### **Consumer Information Center**

The Department of Consumer Affairs (DCA) Consumer Information Center handled 4,010 calls for the Board during the first quart of FY 2025/26 and the average wait time per call was 67 seconds. First quarter call volumes are slightly less than last first quarter FY 2024/25 call volumes. (Attachment B).

#### **Email Communication**

Board staff received 43,935 emails during the first quarter of FY 2025/26. The Registration Unit accounted for the largest share of inquiries, while email volumes in the other units remained consistent with typical levels. (Attachment C)


