

visible to patients in their office. However, the following exemptions apply (BPC §680.5):

- Persons who provide medical services to enrollees of a health care service plan that exclusively contracts with a single medical group in a specific geographic area are exempt.
- Persons who work in a facility licensed under Health and Safety Code (HSC) §1250 or in a clinical laboratory licensed under BPC §1265 are exempt. This exemption includes general acute care hospitals, psychiatric hospitals, correctional treatment centers, nursing facilities, and hospice facilities.

This Bill:

- 1) Allows an employer or agency of a licensee or registrant to make an exception to the requirement that the written notice provided to each client contain the licensee or registrant's full name, license or registration number, type of license, and expiration date based on individual safety concerns in the following settings (BPC §§4980.32, 4989.17, 4996.75, 4999.71):
 - a. An acute psychiatric hospital (defined in HSC §1250)
 - b. A correctional treatment center (defined in HSC §1250)
 - c. Any setting where mental health services are provided to incarcerated individuals under the jurisdiction of a local, state, or federal correctional authority.
- 2) Requires that if these settings exercise this discretion, they must have an established process by which the client may request and obtain sufficient identification information to file a complaint with the Board, that process must be disclosed to the client as part of the written notice, and a copy of the written notice must be preserved as part of the client's records. (BPC §§4980.32, 4989.17, 4996.75, 4999.71)
- 3) Requires that if the discretion is exercised, the licensee or registrant is responsible for ensuring the process to request and obtain the required identifying information to file a complaint with the Board is in place. (BPC §§4980.32, 4989.17, 4996.75, 4999.71)

Comment:

- 1) **Author's Intent.** The author explains that since the passage of SB 1024, constituents working in correctional settings have raised concerns that the requirement to disclose their full name and license number on the required written notice could expose them and their families to safety risks. They emphasize that effective legislation should proactively anticipate potential harm rather than

respond only after it occurs. This bill is intended to address those concerns by strengthening protections for mental health professionals.

- 2) **Background.** All Board licensees and registrants are required to provide each client with a written notice containing specified language stating that they are licensed or registered by the Board and the contact information for the Board where a complaint can be filed, prior to initiating psychotherapy services.

In 2024, the Board sponsored a bill, SB 1024 (Chapter 160, Statutes of 2024), that also required the written notice to contain the licensee or registrant's full name as filled with the Board, their license or registration number, type of license, and expiration date.

Since SB 1024's enactment, Board staff has heard from numerous licensees working with incarcerated populations who have expressed safety concerns about the disclosure requirements. They state that requiring disclosure of their full name and license number may pose significant safety risks to themselves and their families, noting that their job makes them particularly vulnerable to harassment and retaliation.

- 3) **Additional Research.** Staff reached out to several agencies within the correctional system to gather information regarding their complaint processes, their policies to protect providers' personal information, and implementation challenges related to SB 1024. California Correctional Health Care Services (CCHCS), which oversees medical, dental, and mental health care for individuals incarcerated in all of the California Department of Corrections and Rehabilitation's (CDCR) 31 institutions, responded with detailed feedback.

CCHCS confirmed that historically, mental health providers in CDCR facilities typically identify themselves verbally using their last name and professional title (e.g., "Ms. Jones, LCSW"), and written materials generally include only the last name and title unless otherwise required by law. These practices are consistent with CDCR's longstanding security protocols aimed at minimizing risks of harassment or retaliation.

CCHCS also outlined existing policies that protect provider identity, including not using full legal names in patient-facing documents and internal procedures that allow incarcerated individuals to file complaints without needing full provider identification. These include CDCR's Health Care Grievance Process and supervisory review mechanisms that allows leadership to identify the provider even when the patient does not know the full legal name, and in the case of complaints made directly to the Board, CDCR assistance to the Board in identifying the provider.

Concerns regarding the disclosure of full legal names and licensing details were echoed by CCHCS. They noted that while providers have some tools to protect

personal privacy, such as using institutional addresses or professional mailing services, these do not fully address the risks posed by mandatory written disclosures.

- 4) **Previous Board and Committee Discussion.** The Policy and Advocacy Committee discussed this issue at its meetings on October 24, 2025 and January 15, 2026. At the January 15, 2026 meeting, the Board directed staff to bring draft language to the Board for consideration as a legislative proposal.

The Board considered the proposed language at its February 20, 2026 meeting. However, Board members noted transparency concerns, especially in light of the current national climate. They opted not to move forward with pursuing the proposed language as legislation.

However, Senator Ochoa Bogh, who previously carried SB 1024, has emphasized that this matter was brought to her as a constituent concern and presents safety implications for therapists working with incarcerated individuals. As a result, she has chosen to proceed with the legislation.

- 5) **Previous Legislation.** SB 1024 (Ochoa Bogh, Chapter 160, Statutes of 2024) added the requirement that the notice that Board licensees or registrants provide to their client upon initiating psychotherapy services must contain the licensee or registrant's full name as filled with the Board, their license or registration number, type of license, and expiration date.
- 6) **Policy and Advocacy Recommendation.** At its April 17, 2026 meeting, the Policy and Advocacy Committee opted to remain neutral or take no position on this bill.

SB 993, as amended, Ochoa Bogh. ~~Marriage and family therapists. Board of Behavioral Sciences: licensees: notices.~~

Existing law establishes the Board of Behavioral Sciences and sets forth its powers and duties, including, but not limited to, the licensing, registration, and regulation of marriage and family ~~therapists. therapists, educational psychologists, clinical social workers, and professional clinical counselors.~~ Existing law requires a marriage and family therapist ~~these licensees and registrants~~ to provide a client with a written notice stating that the board receives and responds to complaints regarding services provided by ~~marriage and family therapists the licensee or registrant~~ and containing specified information about the ~~therapist licensee or registrant~~ and their license.

This bill would authorize the employing entity or agency of the ~~therapist, licensee or registrant,~~ in specified practice settings, to exercise discretion whether to disclose any or all of the information about the ~~therapist licensee or registrant~~ and their license in the notice based on individual safety concerns if certain requirements are met.
