ASSOCIATE PROFESSIONAL CLINICAL COUNSELOR SUPERVISOR INFORMATION & QUALIFICATIONS

A licensed mental health professional who provides supervision to an Associate Professional Clinical Counselor (APCC) or applicant who is pursuing LPCC licensure must meet certain minimum qualifications. This document is a summary. For complete information, please review the [Statutes and Regulations](#) pertaining to LPCC licensure.

Requirements Applicable to ALL Supervisors

- Possess a current and active California license that is not under suspension or probation as one of the following:
 - Licensed Marriage and Family Therapist (LMFT)
 - Licensed Clinical Social Worker (LCSW)
 - Licensed Professional Clinical Counselor (LPCC)
 - Licensed Educational Psychologist (LEP)*
 - Licensed Clinical Psychologist
 - Licensed Physician and Surgeon certified in Psychiatry by the American Board of Psychiatry and Neurology
- Have been licensed in California or any other state for at least two (2) years out of the last five (5) years prior to the commencement of supervision.
- Have practiced psychotherapy during at least two (2) years out of the last five (5) years prior to the commencement of supervision (or, if an LEP, has provided psychological counseling pursuant to Business and Professions Code (BPC) section 4989.14) **OR**
- Provided direct supervision to APCCs, Marriage and Family Therapist Trainees, Associate Marriage and Family Therapists, or Associate Clinical Social Workers who perform psychotherapy during at least two (2) years out of the last five (5) years prior to the commencement of supervision. Supervision of psychotherapy performed by a student shall be accepted if substantially equivalent to the supervision required for registrants.
- Sign and comply with the *Supervisor Responsibility Statement*

**LEPs may only supervise the provision of educationally related mental health services consistent with the LEP scope of practice described in BPC section 4989.14, up to a maximum of 1,200 hours.*

Supervisor Training Requirements

LMFTs, LCSWs, LPCCs and LEPs must complete a minimum of six (6) hours of supervision training within 60 days of commencement of supervision, and six (6) hours of supervision training each renewal period. *NOTE: Licensed Clinical Psychologists and Psychiatrists are exempt from this requirement.*
